COURSE DESCRIPTION

Deceptive Behavioral Detection 2.0 is a specialized 10 hour training program designed to give law enforcement officers practical, courtroom defensible skills in identifying verbal and non verbal deception during roadside encounters, interviews, and interdiction stops. This course blends behavioral science, cultural awareness, and real world interdiction experience to prepare officers for the realities of field interviews. Students will learn how the prefrontal cortex, limbic system, and temporal lobes drive deceptive responses, how limbic reactions manifest under stress, and how cultural differences influence both verbal and non verbal communication. Instruction covers the four phases of deception which are preparation, delivery, defense, and fallout and shows officers how to recognize deviations across each phase. The class emphasizes establishing baselines, detecting pacifying behaviors, spotting rehearsed versus spontaneous deception, and applying elicitation strategies to build reasonable suspicion and probable cause. The course is taught by Nick Jackson, a nationally recognized interdiction instructor with over 14 years of law enforcement service including a decade dedicated to narcotics and criminal interdiction. He has seized millions in illicit U S currency, thousands of kilograms of controlled substances, and made hundreds of felony arrests. His courtroom tested teaching gives officers practical tools they can apply immediately in the field.

KEY TRAINING POINTS

- Recognizing verbal and non-verbal deceptive behaviors
- Establishing baselines and identifying deviations
- Pacifying behaviors and non-verbal leakage
- Distinguishing nervousness from deception
- Spotting rehearsed vs. spontaneous responses
- Linking behavioral changes to reasonable suspicion and probable cause
- Articulating deception findings for reports and testimony

PRACTICAL APPLICATION

Students will analyze real traffic stop and interview footage, participate in scenario-based roadside interview exercises, and practice applying elicitation strategies with one another. Officers will leave the training able to identify and articulate deceptive behavior in a way that withstands courtroom scrutiny, ensuring both investigative success and legal defensibility.

COURSE DESCRIPTION

Interdiction Academy 2.0 is a modernized, courtroom-defensible training program designed for law enforcement officers who want to sharpen their ability to detect and disrupt criminal activity on America's roadways. PRACTICAL APPLICATION

Students will review dash-cam and body-cam footage from real traffic stops, engage in structured roadside interview exercises, and practice articulating observations for reports and testimony. The course is designed not just to teach theory but to give officers practical tools that hold up both on the roadside and in the courtroom.
